Base oil severely refined: Not carcinogenic in animal studies. Representative material passes IP-346, Modified Ames test, and/or other screening tests. Dermal and inhalation studies showed minimal effects; lung non-specific infiltration of immune cells, oil deposition and minimal granuloma formation. Not sensitizing in test animals. Aryl thiophosphate: Effects on the liver, adrenals, thyroid, blood and reproductive organs were seen in rats after repeated oral gavage at high doses. In a reproduction/developmental toxicity screening study, repeated oral gavage of rats with the aryl thiophosphate at high doses that produced maternal toxicity resulted in litter loss, decreased number of implantation sites and decreased number of live pups.
